1. The Government of South Sudan has allocated funds for the operation of the **Public Procurement and Disposal of Assets Authority (PPDAA)** and part of funds will be used to cover eligible payment under the contract for **Supply of Fuel and Lubricants for PPDAA for F/y 2024/25**.
2. The PPDAA is now inviting the sealed bids from eligible bidders for **Supply of Fuel and Lubricants in the Juba City for the F/y 2024/25**.
3. Bidding will be conducted through the **National Competitive Bidding** procedures as specified in the Public Procurement and Disposal of Assets Act, 2018 and Public Procurement and Disposal of Assets Regulations 2024 and is open to all **eligible South Sudanese<sup>1</sup>** bidders as defined in the Act and the Regulations. Bidders must present proof of their Registration with PPDAA as provided in the Act and the Regulations.
4. Interested eligible Bidders may obtain further information from the **Head of Procurement Unit of PPDAA, Mobile No. xxxxxx** and inspect the bidding documents during **office hours 9:00 am to 3:00 pm Juba** time at the address given below.
5. A complete set of bidding documents in **English language** may obtained by eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee **of 300,000 (Three Hundred Thousand) South Sudanese Pounds (SSP)** or a convertible currency and the method of the payment **will be cash**. An official receipt shall be submitted together with the bid evidencing the payment of fees.
6. Bids must be delivered to the address below on or before **11:00 am, Tuesday 21<sup>st</sup> February 2025**. Electronic bidding **will not** be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on **11:00 am, Tuesday 21<sup>st</sup> February 2025**.
7. All bids must be accompanied by a **Bid Securing Declaration as appropriate using the Format provided in the Bidding Documents**
