The Government of South Sudan has allocated funds for the operation of the **Public Procurement and Disposal of Assets Authority (PPDAA)** and part of funds will be used to cover eligible payment under the contract for **the Construction of Office Building, Car Parking Space and Associated Works**.
2. The PPDAA is now inviting sealed bids from eligible bidders for **Construction of 9 Storey Building in Juba City with approximately 4,000 square meters of Office Building and 5,000 paved open car parking area and other associated works**.
1. Bidding will be conducted through the **International Competitive Bidding** procedures as specified in the Public Procurement and Disposal of Assets Act, 2018 and Public Procurement and Disposal of Assets Regulations 2024 and is open **to all eligible¹** bidders as defined in the Act and the Regulations. **Bidders must present proof of their Registration with PPDAA as provided in the Act and the Regulations**.
3. Interested eligible Bidders may obtain further information from the **Head of Procurement Unit of PPDAA, Mobile No. xxxxxx** and inspect the bidding documents during **office hours 9:00 am to 3:00 pm Juba time** at the address given below.
4. A complete set of bidding documents in **English language** may obtained by eligible bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee **of 1,000,000 (One Million) South Sudanese Pounds (SSP)** or a convertible currency and the method of the payment **will be cash**. An official receipt shall be submitted together with the bid evidencing the payment of fees.
5. Bids must be delivered to the address below on or before **11:00 am, Friday 28th February 2025**. Electronic bidding **will not** be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on **11:00 am, Friday 28th February 2025**
6. All bids must be accompanied by a **Bid Security amounting to 450,000,000 South Sudanese Pounds or a convertible Currency** using the Format provided in the Bidding Documents
