## Contract Agreement

THIS AGREEMENT made the     day of June, 2026.

BETWEEN

- (1) **Ministry of Finance and Planning** of the Government of South Sudan and having its principal place of business at the Ministerial Complex, Juba (hereinafter called "the Purchaser"), of the one part, and
- (2) **Chang Jiang Limited** a company incorporated under the laws of South Sudan and having its principal place of business at Hai Malakal, Juba, Republic of South Sudan (hereinafter called "the Supplier"), of the other part:

WHEREAS the Purchaser invited Bids for certain Goods and ancillary services, viz., for the **Supply and Installation of Furniture and Fitting** and has accepted a Bid by the Supplier for the supply of those Goods and related services at a total sum of **One Hundred and Forty-two Thousand, Nine Hundred and Ninety United States Dollars (USD142,990)**.

The Purchaser and the Supplier agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Contract documents referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement. This Agreement shall prevail over all other contract documents.
  - (a) the Letter of Acceptance
  - (b) Letter of Bid - Technical /Financial Part
  - (c) the Addenda Nos. (Nil)
  - (d) Special Conditions of Contract
  - (e) General Conditions of Contract
  - (f) the Specification (including Schedule of Requirements and Technical Specifications)
  - (g) the completed Schedules (including Price Schedules)
  - (h) any other document listed in GCC as forming part of the Contract
3. In consideration of the payments to be made by the Purchaser to the Supplier as specified in this Agreement, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Services and the remedying of defects therein, the Contract Price or such

other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
